## Schedule of Fees and Charges for Pre 1 July 2014 Residents From 1 July 2016

\*This Schedule only applies for residents who are classified under the  
*Aged Care (Transitional Provisions) Act 1997\**

Residents who were in a hostel on 30 September 1997 and who are NOT currently at a home that was a nursing home before 1 October 1997 will receive a reduction of 80 cents per day to their basic daily fee.

### **Maximum Basic Daily Fee for Residents Eligible for Basic Daily Fee Supplement<sup>1</sup>**

Standard Resident contribution <sup>2</sup> – includes respite residents	up to \$47.69
Protected Resident contribution <sup>2</sup>	up to \$43.43

Non-Standard Resident Contribution <sup>2</sup>	up to \$54.22

The Basic Daily Fee Supplement is payable to aged care providers on behalf of non-pensioners who do not hold a Commonwealth Seniors Health Card and who were in permanent residential care on 30 June 2012. To receive the supplement, providers must notify the Department of Human Services that they will charge eligible residents no more than the rates above. Residents who were in a hostel on 30 September 1997 and who are NOT currently at a home that was a nursing home before 1 October 1997 will receive a reduction of 80 cents per day to their basic daily fee.

Residents who initially entered care <b>prior to 20 March 2008</b> and agree to roll over a bond of more than 9 times the annual single age pension.	\$186,000

**Accommodation Bond Retention Amounts <sup>9</sup>****Maximum monthly retention amount for residents transferring from 1 July 2016 - 30 June 2017**

for bonds in excess of \$41,940	\$349.50
for bonds no more than \$21,720	\$181.00

- Residents in designated remote areas may be asked to pay an additional \$1.06 per day.

- From 20 March 2008, accommodation charges are capped, even if a resident moves from one home to another, provided that there is not a break in care of more than 28 days (excluding leave).
- Rate remains unchanged for resident's stay in the one home, regardless of annual indexation of the maximum rate for new entrants.
- The Department of Human Services send letters to advise of the amount (does not include flexible care residents).
- And who haven't left permanent residential aged care for more than 28 days before entering care after 20 March 2008.
- Accommodation charge limited to a maximum period of five years and fixed at date of entry even if they have a break in care of more than 28 days.
- Where the bond is between the two thresholds, the maximum monthly retention amount can be calculated by taking 10% of the bond and dividing the result by 12.
